and throughout the community. Marilyn Stewart, CWU Vice-president, presented Chambers with a certificate

and check in appreciation. Chambers shared that often people ask her how she can deal with all the "bad kids" at the detention center. "Bad kids? They are just kids" replies Chambers. It is not unusual for Chambers to be out shopping or even at a drive-through and one of these former "kids" comes up to tell her thank you and shares how they are doing in their adult lives. "This is my ministry," affirms Chambers. "I am thankful for God placing the right people in my life."

In closing, Chambers asked the attendees to be in prayer over the future of the

detention center and the four plans being deliberated and that the right decision will be made.

Church Women United is a racially, culturally, and theologically inclusive Christian women's movement. The group meets four times a year at different local churches: in March for World Day of Prayer, in May for Friendship Day, in July for Human Rights Celebration, and in November for World Community Day. According to Assistant Secretary Caroline Martin, the national organization provides the theme and local units add their own spin to the observances. famous. There seems to be a hungering and thirsting to know all we can about the celebrity world. Knowing the latest gossip seems to thrill the masses. I sometimes believe that there must be something wrong with me for not wanting to know the latest squeeze of Hollywood's elite. I realized long ago that people are people, and we shouldn't elevate them because they are called 'stars.'

The Scripture talks about the rich and famous. Solomon was an individual that could make more claims to wealth and stardom than anyone that has ever lived. What did Solomon have to say about the rich and famous? The text above shows what he said.

Solomon's words could be echoed by many who have traveled down the same road Solomon did. He begins in verse 12 by reminding us that he was a famous and powerful man as well. It doesn't seem as though one could ask for much more in life than these things. In verse 16,

Solomon tells us that he was a man of great riches. The Bible tells us that he was the wisest man who ever lived, but did you know he was the richest man who ever lived? He went as far as to say in the last part of verse 16 that he believed he had arrived. He not only knew it all, but he had it all.

If we ended the story now it would be much easier to convey to others. However, Solomon had much more to say concerning his quest of happiness and contentment. In verse 17 Solomon proclaims that he tried it all. He pulled out all the stops and lived life to the full extent. Solomon continues elaborating on his life by one verse of summarization in chapter 2:11, "Then I looked on all the works that my hands had wrought, and on the labor that I had labored to do: and, behold, all was vanity





The day of the moon landing: a march on Marion

t 4:18 pm on Sunday, July 20, 1969, man landed on the moon. Astronauts Neil Armstrong and Buzz Aldrin, from that rickety little piece of machinery they called a lunar module, announced to the world that "The Eagle has landed," and a large chunk of humankind breathed a collective sigh of

In Marion, at just about that same time that same day, Henry C. Mills, a man with a past and a fearless presence about him, stood on the south steps—the Fourth Street side—of the Grant County Courthouse, gripped a sheaf of pages and began to read aloud:

"Manifesto of the National Association for the Advancement of Colored People. Let it be known that we of the Marion Branch are grateful for the support given by the righteous thinking people of our community...Ît is our pledge: We shall pursue the following demands with as much vigor as we can marshal."

He continued for about 15 minutes: Employment. Housing. Education. Police. Public accommodations. Recreation. News media.

Best estimates are that about 600 or 700 people, mainly African American, were gathered around him on that hot July Sunday a

police patrolled the perimeter of the crowd, which spilled out into the traffic lanes on Fourth Street. This was the endpoint of a march that had begun at 1 pm on 26th Street in south Marion near Marion High School and moved north along Nebraska Street to the

Tensions were high and

It was the day of the "March on Marion," a civil rights demonstration and enumeration of grievances that had been long in coming and was attended by civil rights and African American leaders from across the Midwest.

The central figure that day was Father James Groppi, a firebrand speaker and Catholic priest from Milwaukee, WI, who came to Marion in the company of a busload of his supporters from inner city Milwaukee. To white observers, unaccustomed to the racial confrontation tactics of the era, Father Groppi and his people appeared both menacing and intimidating. From the perspective of 50 years, of course, they were neither.

Groppi took the microphone and told the crowd that boycott was the antidote to discrimination.

"If they're not gonna hire vou, boycott them. If the school system is no good,

boycott it. The man ain't gonna give you nothing unless you demand it," the priest said, setting the tenor and tempo for that after-

The Milwaukee contingent departed later that day. Father Groppi later left the priesthood, married and continued to work in civil rights until his death in 1985 at age 55.

But it was Henry Mills who spoke of Marion and its specific problems that day. There were the universal issues, which are still being dealt with: fair housing; pay for sanitation workers; black representation throughout the school system, including, in the Manifesto that day, a demand that "the NAACP be allowed to name an appointment to the

Marion school board."

There was focus on General Motors, then pretty much universally known in Marion as "Fisher Body."

"Fisher Body: clean its house of right wing activities, including immediately the distribution of Ku Klux Klan pamphlets"

Next came this: "Listen to this carefully," Mills said. "The United Auto Worker President Walter Reuther immediately suspend Mr. James Dutton as Fisher Body Division of General Motors UAW because of his right wing activity.'

So it went that day in Marion as men emerged on the moon.

The newspaper coverage included the mandatory police report of "two minor incidents." One was a smoke bomb lobbed into the intersection at Fourth and Washington Streets; the other, a man wearing a red crash helmet attempt to reach the microphone at the podium on the courthouse steps. He was detained by

Next day, Mayor Gene Moore denied everything. Said he of Father Groppi: "Here's a man who has never been to this town before and comes in to make some statements and then turns around and leaves town. He doesn't know what he's talking about." Thus spake


