## Marion Police enter high-speed chase

Marion Police apprehended a man after a highspeed chase on Monday, May 17, at 10:45 p.m.

Sgt. George Kilgren was on a routine patrol in the area of 1st and 2nd streets where he witnessed a white male riding a blue and white dirk bike veer into the alley between 1st and 2nd streets without usage of a left turn signal.

Sgt. Kilgren activated his red and blue lights to initiate a traffic stop.

The motorcyclist, Kevin L. O'Banion, age 51, fled to Baldwin Avenue, west on 1st St at a high rate of speed. O'Banion ran the stops signs at Forest and Butler Avenue to 1st and Short St. He then traveled south in the field until coming to 2nd Street. He began to travel the wrong way down 2nd Street until coming to Park Avenue where he turned north and again began to accelerate at a high rate of speed. O'Banion reached Spencer Avenue, where he turned west and continued traveling west on Spencer at a high rate of speed until reaching Miller Avenue. He then went through the parking

the exit going out onto SR 18 West. He pulled the dirt bike off the road and into the grass on the shoulder and slowed to a near stop to attempt to turn himself around 180 degrees. Sgt. Kilgren pulled his vehicle across in front of him and Officer Andry did the same behind him in an attempt to box him in. While he was slowed to a near stop, Sgt. Kilgren exited his vehicle and attempted to grab and pull the driver off the dirt bike while he was moving slowly.

As Sgt. Kilgren's fingertips grasped O'Banion's clothing, he accelerated and pulled away. It was then another MPD vehicle driven by Officer Tommie Ison, who was attempting to turn around, struck Sgt. Kilgren's right knee with his push bumper. It knocked Sgt. Kilgren off balance but he was able to regain his footing and got back into his police vehicle.

had gotten onto Miller Avenue and was traveling south from 2nd Street. Sgt. Kilgren reentered the pursuit and followed while the vehicle drove south on Miller, running stop signs at 9th and 16th street.

By this time, the dirt bike

to travel down 26th Street. At Double H Plastics Manufacturing, 2548 W 26th, there was a train traveling south that was blocking 26th Street. The dirt bike came to the train and then began to drive parallel to the train going south in a freshly planted farmers field. The field was extremely muddy. The dirt bike was struggling to maintain traction.

Sgt. Kilgren was able to catch up to the vehicle and stayed behind and to the left of it. The dirt bike suddenly veered to the left away from the train, at which time Sgt. Kilgren inadvertently struck the dirt bike with the front of his vehicle, while traveling at a slow speed of approximately 5-10 mph.

Sgt. Kilgren exited his vehicle and too the suspect into custody. The suspect was transported to Marion General Hospital for medical clearance before he was taken to the Grant County Jail.

O'Banion was charged with resisting law enforcement with a motor vehicle and reckless driving. The bond was \$605 cash.

Sgt. Kilgren was treated and released from Marion General Hospital with minor abrasions.
