After going through rehab, David twice tested negative for COVID-19, and was able to return home to his family.

The Henry's believed that the Lord had provided the miracle that they had yearned for, but that He had also provided Isaiah a platform, from which he was able to testify to God's faithfulness to his family.

"Not only has my dad gotten better, but we are getting these opportunities to minister to so many people about how awesome, amazing, and how true God is and how loving he is," Henry said. "That's not what I prayed for, but I am overwhelmed with all the opportunities we have gotten. God completely blew me away. My prayers were small, compared to His answer. God opened my eyes to really see how much He cares."

"The way God is using healing me, it is totally worth it," David Henry added. "There have been people all around the country that have heard our story and the miracle that God is. It sounds sappy, but the honest truth is that it was all worth it."

which included sending food, praying with them, sending them encouraging letters, and reaching out via phone calls or text messages.

And one of those calls came from a source that Isaiah did not expect.

At first, he thought it was a prank call from a random number, but it turned out to be from Isaiah's Ugandan family, reaching out to comfort the family in their time of need.

According to Isaiah, his real father is a Muslim, and per Ugandan culture, the

rest of the family is expected to align themselves with the faith of the head of the household.

Throughout this crisis, Isaiah saw the Lord working through his family and believes that they are one step closer to embracing his faith.

"That just blew me away. That is what I want," Isaiah said. "I asked them, 'Is it Jesus that you are praying to?' And my older siblings said, 'Yes, we are praying to Jesus.' That just encouraged me so much. Through this situation, I was able to see hope for my family."

The COVID-19 pandemic is unlike anything many have seen in a lifetime. Millions upon millions of people have been affected.

But in the midst of the darkness, stories like the Henry's restore to humanity a sense of the power of hope, fueled by love and faith.

"This has been a really amazing opportunity for them to experience the power of Christ," David Henry said. "We are thankful that we are able to have this great relationship with them, and I really believe that when it is all said and done, Isaiah's going to have two Christian families."
