Taylor University’s Interim President Dr. Paige Comstock Cunningham has announced the dates for the rescheduled 2020 Commencement ceremonies and the start of the 2020 fall semester.

Commencement, which was originally scheduled for Saturday, May 23, is now scheduled for Saturday, August 15. Fall semester, which launches the 2020-21 academic year, is scheduled to begin on Aug. 31.

“We have made it to the end of spring semester. Seniors are jumping into finals week and I am so thankful for the way you have hung in there and pivoted to finish your courses in a different way,” she said during a video announcement.

“Secondly, to our faculty – your creativity, your endurance, and your commitment to every single student is such an inspira-
