Recently, during a visit from our oldest, it was heart-warming to hear my daughters talk and laugh about how in many family photos my dad had the same shirt on. When they asked him about the shirt, he commented there was nothing wrong with it, it was just a little thinner and cooler as years went on.

It had become a family joke to see how many photos the children could find Grandpa in the same shirt year after year for family gatherings. It was not like he did not have a closet full of dress shirts, it just

ing with us."

Lastly, Dr. David Moore, Public Health Officer with the Grant County Health Department, encouraged the Marion community to stay the course. While much progress has been made, there is still much work left to be done.

"These seventy days have felt like a lifetime," Moore said. "A whole lot has changed for all of us. and it's been a long, long journey to get here. The virus is still the same and the human body is still the same, but we did something different, and it has slowed it down.

"We can't do that forever. We need to reopen our country. We need to reopen our county. But we need to do it in a thoughtful way, and we need to monitor and respond. We need to be sensitive to one another. We know it's going to be different than what it was before. We can do this, but it's going to take us being patient and persistent."
