## Council extends 'olive branch' to mayor

Marion's City Council, embroiled in what some of its members believed was a stalemate with Mayor Jess Alumbaugh, backed off from its aggressive stance Tuesday night and issued what one council member described as an "olive branch" to the city administration.

Alumbaugh and three members of his staff appeared at Tuesday's meeting under subpoena issued by the council two week ago. They had come prepared, as ordered by the subpoenas, to provide answers to 11 questions posed by the council last month regarding the source of money to pay about \$1.6 million in legal fees connected with a lawsuit involving the failed "Old YMCA" renovation project of the previous Wayne Seybold administration.

Only one of the 11 questions was raised at all by the council members, who, instead seemed to be seeking ways to back away from the

confrontation with the mayor.

The lone question from the July list dealt with the collection and disbursal of money said to have been donated by anonymous citizens to encourage the lawsuit in its formative stages nearly four years ago.

Council President Deborah Cain, who had used her authority to issue the subpoenas to the mayor and his staff, asked who had donated the money, how much

Safe to say, despite her youth, she has already made a significant impact.


For all of her accomplishments in STEM-related fields, particularly in the field of molecular biology, Weaver, a 2004 Marion High School graduate, will be inducted into the
