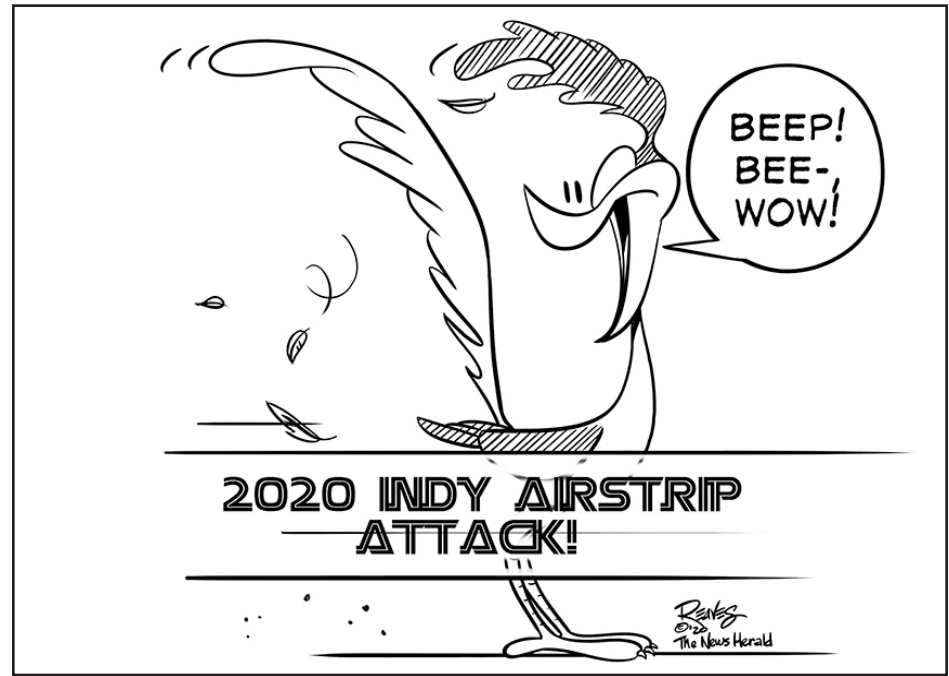

ford Mental Health that has been championed over the last 43 years by Paul Kuczora,” DiMatteo said. She will work with Kuczora until she assumes the CEO role in September.  
“Grant-Blackford has a rich history of providing vital services to some of the most vulnerable individuals since 1950. As the landscape is ever-changing in our world, the potential for opportunity to positively impact our communities through the work of the Grant-Blackford team is limitless,” she said. “I eagerly await the opportunity to share my passion, education and lived experience

with the staff and individuals served by Grant-Blackford.”  
Grant-Blackford offices are housed in the Cornerstone building adjacent to Marion General Hospital on Wabash Avenue in Marion. It operates programs under several names and in 21 locations in the Marion and Hartford City areas.  
DiMatteo will be the third director of Grant-Blackford since its creation in 1975 under the leadership of John Brubaker. He was succeeded by John Creek and Kuczoa assumed leadership in 1977.  
The corporation operates Cornerstone Behavioral Health Center, Milestone

Addiction Services, and Keystone Family Resource Center in Marion and Hester Hollis Concern Center in Hartford City. It is governed by a volunteer board of directors. It provides mental health and substance abuse services to residents primarily in Grant and Blackford Counties. Grant-Blackford employs over 170 people and serves over 3,000 outpatients and over 600 inpatients per year.  
In her free time, DiMatteo enjoys spending time with her husband, Steve, her three children and two grandchildren. She and her family enjoy boating, camping and motorcycling.


