The day before, on Saturday, Aug. 1, the governor put in place a mask mandate that all in the state must wear a mask, no matter where they were including church.

That did not sit well with my aunt, who made it clear when we arrived at her house that Sunday morning that she was not at all happy about the new mask man-

"This is going to start a civil war," she exclaimed, to which my oldest daughter asked her if she did not want this pandemic to end. "Well, of course, I do," Aunt Elaine replied. "I just don't want to wear a mask."

Laura on the other hand will do anything she has to do to get Covid 19 to go away, wanting nothing more right now than to get back to in person classes and be able to walk across the stage at University of Wisconsin, Milwaukee's graduation on May 16 where she will receive her master's degree in architecture.

To Laura wearing a mask is an easy task, and something she has no problem making sure her sisters comply with, constantly asking them if they had their mask during our weekend visit.

Of course, my aunt had to question the security guard if that sign really applied to her, as she takes daily walks through the campus area.

Yes, the security guard told her, even you.

So, as my Aunt continues to find more restrictions in life, I pray she will keep her spirits up and realize that if we all mask up and social distance, hopefully this will be over sooner than later.

## Indianapolis man dies in Grant County crash

Monday, Aug. 3, at approximately 6:56 p.m., officers from the Indiana State Police and the Grant County Sheriff's Department responded to a four vehicle crash on I-69 near the 267 mile marker, in which an Indianapolis man

The preliminary crash investigation by Senior Trooper Jeremy Perez revealed that Mansharan Malhi, 23, Sydney, Nova Scotia was driving a 2020 Freightliner semi-tractor, pulling a box trailer, southbound on I-69. Timothy Mizell, 50, Wayne, MI was driving a 2001 Peterbilt semitractor, pulling a livestock trailer, southbound on I-69.

He was driving behind the

Freightliner. Gary Byrd, 62, Indianapolis, IN was driving a 2018 Kia Sedona southbound on I-69 behind the Peterbilt. Charles Wright Jr, 62, Markleville, IN was driving a 2020 International semi-tractor, pulling a box trailer, southbound on I-69 behind the

The four vehicles encountered a traffic back up, near a work zone, at the 267 mile marker. The Freightliner, the Peterbilt, and the Kia slowed down, but the International did not. The International rear-ended the Kia, pushing the Kia into the livestock trailer of the Peterbilt. The crash impact caused the Peter-

bilt to rear-end the Freight-

Byrd was pronounced deceased at the crash scene. Wright Jr was transported to Marion General Hospital with non-life threatening injuries. Mizell and Malhi were not injured.

This is an ongoing investigation. At this time neither the consumption of alcoholic beverages nor narcotics is suspected as having contributed to this crash.

Trooper Perez was assisted at the crash scene by the Grant County Sheriff's Department, the Vanburen Police Department, the Vanburen Fire Department, the Marion Fire Department, and the Indiana Department of Transportation.
