'Home of the Hog' history dusted off and retold to locals


COVID has taken so much from all of us. Lives and times destroyed or deferred. And especially as summer draws to a close we consider the times that did not happen in 2020. The county fair. James Dean Days. Mississinewa 1812. And one that had planned so much for its special year: Hog Daze, that great gathering of motorcyclists, of bikers, that has formed in Marion to pay homage to the pioneer riders of a century ago.

And that is precisely the point: A century, 100 years this week since the day that those daring young men and their two-wheeled machines brought home the hog.

You may have heard the story, but it is worth retelling today, mainly because those who wanted to play out the little drama that occurred here on Labor Day weekend of 1920 won't be allowed. COVID, you

For better than a decade now, ever since a young lady named Aletha Dunstan came upon the dusty history, we have set aside a couple of days to let the men and women and their machines do their thing for "Hog Daze." They have

gathered at Ballard Field in east Marion for fun, fellowship, riding, and maybe an adult beverage or two. This year, in an expansion effort, they were to have moved a half-mile east to the Grant County 4-H Fairgrounds. That is not to be. Maybe next year, they hope.

But it won't be the same. It won't be a century. Instead it will be 101 years since that running of the International Marion Motorcycle Road Race, 200 miles on a five-mile course laid out, mainly on dirt roads, just southwest of Marion. Forty laps and an estimated 15,000 spectators along the route. It was the second annual running of the Marion race - the "Cornfield Classic" — in a revitalization of a young and dangerous sport that had been put on the shelf for World War I.

Some reports said that Walter Davidson and William Harley had both come to Marion that day. Mr. Davidson and Mr. Harley both here. That sound familiar? Harley and Davidson, as in Harley-Davidson, back then and still today the marquee name in motorcycles.

Race day came and Ray Weishaar, a hotshot cyclist out of Oklahoma and Kansas was riding for team Harley-Davidson. He was 29 years old and had been riding for Harley-Davidson since 1916.

Somewhere along the way that day Weishaar, who was nothing if not a promotor, had acquired a newborn runt piglet from a farm somewhere along the course. He carried it under his arm in a pre-race stroll through the paddocks.

Weishaar put the pig aside, mounted his motorcycle and road a blistering race, an average of 71 miles an hour and a new record for a 200-mile event. He cut 18 minutes off the time

from the race the previous year.


And then the moment came: Weishaar reclaimed the piglet, put it on his lap for post-race photos and thus was born the moniker of the hog for all things Harley-Davidson.

Sports writers and photographers covering the race loved it. Weishaar and his piglet – his hog – which he had named Johnny. It's unclear whether the pig actually rode the victory lap with Weishaar, but that's not important. What was important was that the photographers bought into the moment: Pictures of Weishaar holding the animal, feeding the piglet from a baby bottle, straddling the racing machine with "Johnny" in his lap.

Weishaar went on to win other races in the fast growing sport. He was a star.

That all ended in April 1924. Weishaar was running his Harley-Davidson against the Indian brand motorcycle in a race in suburban Los Angeles. His machine went into a high-speed wobble, he lost control, went through a wooden fence and crashed, but didn't seem to be seriously injured. .

He was taken to LA Gen-

eral Hospital by his wife, Emma, as a precaution, just to be checked out. The injuries were internal and they were serious. He died that evening. He was 33 years old.

And that brings us back to Marion in 2009. Aletha Dunstan was then the city planner in the Wayne Sey-

bold administration. She was researching a detailed plan for Marion future development and came onto the references to the race course and its few glorious years. And that led her to Ray Weishaar. And that led her to "Johnny."

All of it right here in the "Home of the Hog".
