

study the parents of Moses (Verse 23). The story is found in Exodus 2:1-10. This story unfolds because the people of Israel had become so great in numbers that Pharaoh was fearful they would rise up against him, so he enslaved them. He also put out a decree that all male newborn Jewish children would be put to death. He had to do something to keep the Jews from multiplying.

When Moses was born, his parents could not bring themselves to turn him over to the Pharaoh to be killed. They hid him for three months and realized that something had to be done. In Hebrews 11:23 it tells us this child was beautiful and there was something very special about him. They did what they did because they weren't afraid of the Pharaoh's command.

Realizing they couldn't keep the child, they had to devise a plan for Moses. They put Moses in a basket and waited for Pharaoh's daughter to come down to the river to bathe, and then they set the basket assail. It floated downstream where he could be seen, and Pharaoh's daughter had a maiden retrieve it. She looked upstream and saw Jochebed (Moses' mother), and she called her to come. She was told to take the baby and nurse it until the appointed time when Pharaoh's daughter would come and take him to live with her. What an amazing

that is commended here. The natural affections the parents had for this child became subservient to faith. This story represents many principles, but one of the most profound is they overcame fear and embraced faith. Could you imagine how they felt when they pushed that basket into the river? All of the emotions they must have had. This story also represents two parents who were in total agreement what needed to be done. It was a decision that promoted the good of the child over any ambitions they could have had for him.

Being a parent helps me realize just how much of a sacrifice they made, and the depth of faith they had to have to trust God for the

right outcome. Killing the child was never an option, so what could they do? When God is working in and through our lives we must expect a good outcome. He has never let us down, and He never will. Sometimes it is not the easy way when we trust God, but remember, it is the only way. "If God be for us, who can be against us" (Romans 8:31)? There is no doubt that He is the God that cannot fail, so I hope that you will put your faith and trust in Him.
