required to file a certificate with the Indiana Department of Local Government Finance stating what action was taken.

In conclusion, Alumbaugh stated the CARES ACT requires he be charged with the distribution of the funds to certify under oath that the uses of the funds are consistent with the CARES Act, and he believes he cannot make that certification under the Council's requirements.

"I am not against first responders, as some on the Council have suggested," Alumbaugh said. "Our first responders have a unique duty to protect all of us and for that I am, and all of you should be, eternally grateful. But this is about what the law allows and my obligation is to enforce the law.

"We are seeing increased numbers of cases locally and across the country. They are still two months before the CARES act program expires. If we spend all of the CARES funds now as the Council would have us do, we will have nothing left to help us defray other COVID related expenses in the next two months."

Alumbaugh said that he

wants to do everything in his power to compensate Marion's first responders, firefighters, and police officers for their hard work in these trying times, but wants to do so within the confines of the law and the structure of the CARES

"What we were most concerned about is there are different governmental agencies involved – local, state, and national - and we are worried that a federal audit could come in behind the state audit," Alumbuagh said. "We are trying to find out more information, and make sure we don't get surprised and face a financial issue that we are really not prepared for. We aren't against hazard pay, we just want to be sure that if we give it, it's something that we are going to get reimbursed for."

Alumbaugh is preparing for the council to override, and he went on to say that he would veto again. There is a chance that this issue will have to be settled in court, and while Alumbaugh does not want to go down that route, he reiterated that the CARES Act is very clear in how funds are to be distributed.
