Marion man arrested after vehicle pursuit

Recently, a short vehicle and foot pursuit led to the arrest of Daren Haynes, 54, of Marion. Haynes was incarcerated in the Grant County Jail to face criminal charges for felony resisting law enforcement with a vehicle, misdemeanor resisting law enforcement, possession of drug paraphernalia, driving after having been deemed a habitual traffic violator for life, and operating a vehicle having never been licensed.

It was also revealed that Haynes was wanted on an arrest warrant from Grant County for failure to appear for a traffic offense. He was also wanted on an arrest warrant from Howard County for theft or conversion.

At approximately 11:20 p.m. on Friday, Indiana State Police Trooper Edward Titus initiated a traffic stop on a 2000 Pontiac Grand AM near 10th and Poplar Street, in Marion. The driver of the Pontiac, later identified as Haynes, had allegedly failed to signal a lane change. The Pontiac also had a false and fictitious registration plate. Haynes initially pulled the Pontiac over to the roadside, but as Titus was walking up to the car, Haynes purportedly drove away. He led the trooper on a short vehicle pursuit. Haynes stopped the Pontiac near 11th and Poplar Street, eventually exiting the car and attempting to flee on foot. He was captured by Titus and taken into custody.

Further investigation revealed that Haynes was wanted on active arrest warrants from Howard and Grant Counties. He also had allegedly been deemed, by a court, to be a habitual traffic violator for life. Haynes also had never received an operator's license. After Haynes was taken into custody, a subsequent search of him and the Pontiac allegedly revealed drug paraphernalia. He was incarcerated in the Grant County Jail with no bond.
