Wildcats sweep Marian to win Crossroads League Tournament

Whenever IWU and Marian get together, regardless of sport, it is always a hardfought, entertaining affair, and volleyball is no exception

And whenever Marian is across the net from the Wildcats, it always brings out their best.

Behind an incredible defensive effort, particularly from Ana Collar and Havyn Gates, combined with a plethora of offensive production up and down the lineup, the Wildcats won their 11th Crossroads League Tournament Championship in the last 15 seasons in a three-set sweep of the defending NAIA National Champions (25-18, 25-18, 26-24).

Despite having to quarantine over most of the final third of their schedule, the Wildcats came back in early November with a renewed focus and purpose, and their Crossroads League Tournament Championship came as a result of one of their best performances of the 2020 season.

"It was so awesome to see them come together today like they did," IWU Head Coach Candace Moats said. "When we went into quarantine, we were really getting to a peak, and then we kind of lost ourselves a little bit in the quarantine, but the girls fought to come back and hit that peak

offense, particularly reigning Crossroads League
Player of the Year Skyler
Van Note, the Wildcats held
the Knights to a .123 hitting
percentage, one of their
lowest offensive outputs of
the year. IWU, as a team,
combined for 74 digs, and
only allowed one player,
Van Note, to record doubledigit terminations.

"I thought that was the best defense I've seen them play," Moats said. "Marian is phenomenal with their short game, and they just know how to do tips. But we stopped that and took that out, and they didn't know what to do."

While every Wildcat on the floor played a role, it was libero Havyn Gates who stole the show defensively, collecting a teamhigh 25 digs. The sophomore was all over the

floor on Saturday, covering the corners well, diving after loose balls, and frustrating Marian's attackers.

Gates, who has played with many players on the Marian roster, including Van Note, always brings her A-game against Marian, and her steady play kept the Wildcats engaged, playing a key role in the victory.

"We really knew who their money hitters were,

and so just stuck with them and let some other people fly by us," Gates said. "I've played with a lot of them, so I do know how they hit, so for me, it was just having those memories of what their trick shots are. We watched a ton of film, [so] we were ready for everything."

"Havyn is amazing. She is just amazing," Moats added. "She is so savvy in

her defense. She gets mad when she gets 50 digs, and she misses one. She has that grit in her. She's a phenomenal player for us."

Offensively, five Wildcats recorded at least seven kills. Collar, who recorded 23 digs while playing in both the front and back row, led the team with 12 kills.

"I'm super fortunate to

play front row and back row
— you don't get that all the
time," Collar said. "It's a totally different game of volleyball, so being able to get
the opportunity to do that
— I love it. It's a great
time."

Senior Marci Miller, who led several IWU rallies throughout the match, fin-

ished with 10. Rachel Klitzing added 9, while Allison Sparrow and Martina Demarchi each posted seven terminations.

terminations.

Three IWU errors to start the match led to an early 3-0 lead in the first set for Marian, but the Wildcats quickly and efficiently found their rhythm, controlling the match for the rest of the afternoon. IWU battled back to cut Marian's lead to 7-6, before a 4-0 run, which included three kills from Klitzing, gave the Wildcats an advantage they would not relinquish.

A 5-0 surge later in the set put the Wildcats up 16-11, and Miller helped IWU close it out, collecting four kills on four of the Wildcats' final seven points.

The two longtime rivals battled toe-to-toe in the early stages of the second set, before Marian used a 5-0 run to go up 12-8. With momentum seemingly about to slip away, Moats called a much-needed timeout, allowing the girls to regroup and make adjustments.

That timeout changed the course of the set, as the Wildcats regained control with authority.

"We honestly just [told ourselves] to stick to the gameplan," Gates said. "We just told ourselves to put the ball in play and play our game."
