# Common Council covers 2021 budget in latest meeting

As 2021 draws ever closer, the Marion Common Council passed one ordinance and approved a second reading for another in their penultimate meeting of 2020.

Appropriation Ordinance No. 1-2020 was a revised budget for the City of Marion to reflect an increase in the General Fund Levy. According to the Marion City Controller, Julie Flores, the Department of Local Government Finance informed her that the city of Marion had the opportunity to add additional money to the General Fund for the 2021 budget.

As it is the primary operating fund of any city, this increase will help with operating



expenses and services, as well as increase employee payrolls.

Additionally, according to Flores, Mayor Jess Alumbaugh plans to increase wages, providing a five percent raise to public safety and a three percent raise to Marion civilians.

After discussion, the council passed Appropriation Ordinance No.1-2020 passed unanimously and will have a second reading and public hearing on

December 15. Though the 2021 budget was certified in October, the budget will be recertified, if the resolution passes, on the same day.

The second item, General Ordinance No. 17-2020, is an ordinance that will authorize the City of Marion to make temporary loans to meet current running expenses for the use of the General Fund, the Parks and Recreation Fun, the Aviation/Airport Fund, the Park Bond Fund, the Motor Vehicle Highway Fund, and the Cumulative Capital Development Fund.

According to Flores, this has been done every year since she was elected city controller, and even before she was appointed to the position. Essentially, money needs to be borrowed

because the tax draws the city receives in December do not carry through to the month of June of the following year. To counteract this, the city of Marion borrows money from the Indiana Bond Bank each January to meet current running expenses before paying the money back in December. For subsequent years, Flores puts together cash flow charts and projections based on the upcoming year's budget, and after submitting those materials, the Indiana bond bank sends back a draft with the amount of money they believe needs borrowing.

This year, according to Flores, the amount to be borrowed by the city of Marion is down from 2020 and stands at a total of \$1,174,963, which includes

\$704,745 for the General Fund. For comparison, in 2020, Marion borrowed 4.5 million from the Indiana Bond Bank.

"I think that speaks volumes with how well we are doing financially," Flores said. "I was excited to see that we are not going to have to borrow as much.'

By a 6-0 vote, General Ordinance No. 17-2020 also passed unanimously.

Lastly, Dr. Jeremy Case, who has served on the Marion Public Library Board of Trustees for the last 12 years, was reappointed to the position, receiving glowing recommendations from several members of the Marion Common Council.

"He is committed to the library," councilman Mike Cline said. "We've been on the board together for those 12 years. He does more than show up at meetings. He shows up at programs, his kids are there, he uses the library, and he is committed. On the board, he is thoughtful, and for what it's worth, he is a good member of the library."

"Dr. Case is an awesome member of our community," Vice President Luzadder added, "He has stepped forward and helped educationally with the beginning of the Faulkner school, and his track record is wonderful."

Case's reappointment passed with five aye's and an abstention from Cline, who currently serves on the library board with Dr. Case.

Common Council Rules Committee Meeting, Binkerd provided the council with an update on the Long-Term Control Plan, which included an outline of future-needs towards the continuance of the work and towards meeting EPA (Environmental Protection Agency) guidelines.

The EPA established the CSO Long-Term Control Plan in the late 90's, which required that communities with combined sewer overflow structures, like Marion, put together a plan that would mitigate any overflow or discharge from those structures during wet weather.

Back in the late 1800's, Marion's system was constructed in a way that the same pipes in the ground would collect both sanitary waste and stormwater during rain events. In the late 1930s and early 1940s, water treatment plants were established and relief points were inserted so that when heavy rain would come, water would flow into the river instead of flooding basements and streets.

Beginning in the late 1990's, Marion Utilities began to put together their plan, and over the last three decades, they worked towards full EPA compliance

"We've come to a time where it's just not the right thing to do — to that type of an operation to happen," Binkerd said. "So, we've put together this plan to mitigate that.'

In 1974, a flow study was done, showing that 1.2 billion gallons of wastewater was flowing into the river. In 2009, another study was conducted, and revealed that overflow had dropped down

to 182,000,000 gallons. After securing their first bond issue in 2015, which granted Marion Utilities between eight and nine million dollars for projects, and after completing several of those projects, another study was completed earlier this year, which showcased even more improvement.

To meet their goal date of completing every project by 2025, Binkerd and Marion Utilities are looking to secure their second bond, this time for 12.4 million. While Binkerd does not believe that they will use that entire amount, he stated that he just wanted to be safe and not sell Marion Utilities short.

Future projects include updates to the water treatment plant, including installing more vessels to capture heavy water flow.

"The next couple of phases,

and the phase we will be talking about with this particular bond issue will get us a long way towards finalizing this whole thing," Binkerd said. "We should be at about 200,000 gallons. We have accomplished our less than eight events per year, and we've reduced that volume by such a huge and significant amount."

The council —President Deborah Cain, Vice President Brad Luzadder, and Councilman Mike Cline — voted unanimously for further discussion of this upcoming resolution at the next Common Council meeting, to be held on December 15, 2020. After the first reading, the plan is to hold the second reading and public hearing on the resolution during the first meeting of 2021 in early January.
