Thompson brings energy and enthusiasm to the starting lineup, and it has played a key role in IWU’s success throughout this season. His positivity and optimism have helped foster the winning culture which the Wildcats have established this year.

Thompson’s four-point play sparked an 18-0 run for the Wildcats in the following three-plus minutes. Mangas and Maxwell each scored a pair of baskets, while Alderson recorded a three, as the Wildcats built a 24-6 lead with 14:15 remaining in the first half – one they would not relinquish.

“He’s a special kid,” Tonagel said of Thompson III. “It’s all about the intangibles with Michael. He’s a leader, and he is always thinking about other people. When you have a guy on your team that is always trying to elevate his teammates, that stuff spreads, and it’s contagious.”

The Wildcats led by 18 points at halftime, and they continued well, particularly on offense, in the second half. Their lead never dropped below 20, and they

led by as many as 28 before securing the 26-point triumph.

With the win, the Wildcats improved to 13-0 on the season and 6-0 in Crossroads League play. No other team in the Crossroads League has more than two league wins.

As a team, the Wildcats shot a remarkable 62.5 percent from the field (45-of-72) and 59.1 percent (13-of-22) from beyond the arc.

The Wildcats hit the road for a three-game series in Arizona the week before Christmas, taking on Park University, Arizona Christian University, and Benedictine University at Mesa.

“We have to continue [to work] on rebounding and defense,” Tonagel said. “I wasn’t overly pleased with today defensively. Sometimes it’s hard when you’re up 25, but you have to learn to make it harder on the other team. We will try to tighten that up in Phoenix.”

tacked us, but...we weren’t defending. We weren’t stopping the ball. But I thought once we started playing defense and once we settled down, we were able to finish out that first quarter.”

After switching from their half-court defense to their full-court press, the momentum of the contest shifted in Marion’s favor, which allowed the Giants to assume control.

“We slowed them down a little bit when we went into [our press,]” Blackmon said. “[After that,] I think we took control of the tempo of the ball game.”

The Giants ended the first quarter on a 13-0 run, cutting the Legends’ lead to 17-16, and outscored the Legends 18-9 in the second to take an eight-point lead at halftime. Blackmon was a key factor, making three of his four three-point attempts in the stanza.

Fort Wayne North Side was able to trim the Marion advantage to four points at 36-32 early in the third

quarter, but Metzger made several crucial baskets that kept the Giants in the drivers’ seat. His second three of the evening put the Giants back up by seven, and back-to-back makes later in the stanza, including a successful three-point play, firmly put the contest in Marion’s hands.

The Giants’ lead never fell below six points the rest of the way.

In the fourth quarter, the Giants got to the line 17 times due to the Legends’ over aggressiveness on defense, and closed the contest out with authority, knocking down 14. Blackmon went to the line 10 times in the final eight minutes, finishing with nine makes.

Along with Blackmon’s 30 points, Metzger finished with 16 points for the Giants off the bench. Rodney Gipson scored seven points, while Jake McCarthy finished with 10. Jermaine Woods scored two points and had nine rebounds.
