Additionally, across the state, the majority of cases are people under the age of 55, and close to 90 percent have not been vaccinated.

"The numbers are nowhere near as bad as they were back in October, November, December, and January, but make no mistakes they are definitely creeping up," Dr. Shinkaran Srikanth of Marion General Hospital said. "It's worrisome. It's definitely worrisome."

To combat this, Grant County leaders urge the community to continue to receive the vaccine, no matter if it's Pfizer, Moderna, or Johnson and Johnson, as it has proven to be the best weapon in the fight against the virus. As of now, according to Srikanth, studies have shown that the vaccine is efficient for six months, and with further tests, it could prove to be longer. According to the date,
