

## Arrest made in high-speed chase

Two people were charged following a high-speed chase on May 3.

According to a news release from the Marion Police Department:

At approximately 10:33 p.m. May 3, Officer Stephen Konig, while on routine patrol, observed a black and white Ford Crown Victoria that was reported stolen approximately a week ago.

Once behind the vehicle, it immediately turned eastbound on West 22<sup>nd</sup> Street. Once on 22<sup>nd</sup> Street, the vehicle turned southbound on South Boots Street going the wrong direction on a one-way street. Officer Konig activated his emergency red and blue lights to conduct a traffic stop, but the vehicle increased its speed and ignored his light and sirens.

The vehicle continued southbound on South Adams Street at approximately 100-plus miles per hour. The vehicle continued on South Adams Street and Main Street into the city of Jonesboro.

Jonesboro Police Department became the lead car in the pursuit. The vehicle reached a speed of approximately 80 miles per hour on Main Street, disregarding the stop signs at both Sixth and Main streets and 10<sup>th</sup> and Main streets.

The vehicle continued southbound to the area of 12<sup>th</sup> and Main streets where the road came to a dead end. Jonesboro Police Officer Quackenbush approached the vehicle and placed passenger Cecil Johnson in handcuffs, while Jonesboro Police Officer Nathan Ward approached the vehicle and placed driver Russell Hopkins into handcuffs.

Passenger Krystal Long, 33, was questioned concerning the incident and released.

Johnson, 50, was arrested for outstanding warrant issued out of Superior Court III.

Hopkins, 59, was charged with Reckless Driving, Criminal Recklessness, Resisting Law Enforcement with a vehicle and Habitual Traffic Offender.
