## Rep. Spartz hopes to make difference

Rep. Victoria Spartz, the Noblesville Republican who is in her fourth month as a member of the U.S. House of Representatives, seems to be woman of singular determination.

Consider: She announced last week – a year-and-a-half early that she intends to run for re-election to the Fifth District House seat that she won last fall.

Consider: She wants to continue to serve in a legislative assembly that she describes as "completely broken."

Consider: She is the first member of the United States Congress to have been born in what was then the Soviet Union, emigrated to the United States from Ukraine as a teenager, became an American citizen, was employed in the Indiana Attorney General's office, and was selected by Republican caucus to succeed longtime Sen. Luke Kenley in the Indiana General Assembly when he chose to step down.

"If I can't make a difference I'm just wasting my time," the 38-year-old freshman Congresswoman said as she made the rounds of the multi-county district that elected her,

first from a primary field of 15 candidates and then in a three-way race with Democrat Christina Hale and Libertarian Ken Tucker last November. She succeeds Susan Brooks, a four-term Republican from Carmel who chose not to run for re-election.

Spartz waged a campaign in the time of COVID by saturating the district with signs of all sizes that simply focused on her name — Victoria in large letters. Traditional retail campaigning through personal appearance and public speaking was all but eliminated by the response

She forged a campaign in which she said, if elected, she would become "Nancy Pelosi's worst nightmare." In her appearance in

Marion last week she said she has yet to have a meeting with House Speaker Pelosi, "but I have run into her a few times and I was on an elevator with her. "

"Unfortunately the Speaker of the House has so much power anymore that people are afraid," she said of the California Congresswoman. "She said she looked forward to working with me and I told her likewise, but I have not seen

"I have written her several letters and she never responded. I'm not sure that she wants to work with me too much. I am reaching out to both sides and trying to collaborate."

Spartz said she was part of a bi-partisan Congressional delegation that went to the border area of Texas to see immigration conditions at the border.

"Working with the people makes me believe I am in the right place right now," she said "In spite of all the drama, it makes you understand that you can make a difference in people's lives."

"People underestimate how one person can make a difference," she said. "There should not be a dictatorship of any idea. The legislative branch is completely broken. "

"There is a lot at stake for our country and I believe I can be valuable to my constituents and fight for good policy solutions that are badly needed. "
