Students earning no IN (incomplete) or Z (missing) grades for the term, and earning letter grades of computable point value (Satisfactory/Unsatisfactory and Pass/No Pass graded courses do not apply) in 12 or more semester hours, with a semester grade point average between 3.5 and 4.0 are named to the list.
