## Scooter ordinance passed by Marion Common Council

During a brief meeting on Tuesday, General Ordinance No. 4-2021, an ordinance regulating motorized scooter usage in the city of Marion, was passed by the Marion Common Council by a unanimous margin.

Common Council Vice President Brian Cowgill, in accordance with fellow Councilwoman Robin Fouce, President Deb Cain, Jerry Foustnight, City Engineer Mike Graft, Morrell's Scooters' owner Ronald Morrell Jr., and others, believe they have devised an effective ordinance, which will allow the city of Marion to use motorized scooters in a safe and legal

The ordinance will ensure that motorized scooters are operated in a way that is safe for riders, pedestrians, and drivers and are parked in a manner that does not clutter the public right-ofway or obstruct access for pedestrians, cars, bicycles, or buses.

The ordinance goes into effect as soon as Mayor Jess Alumbaugh signs.

Additionally, the Budget Committee will convene on the second and fourth Tuesday of the month at 6:30 p.m. until further notice, according to Cain. The committee plans to continue discussion on the American Rescue Plan money, as well as other budgetary items.
