

CASA of Grant County announces return of annual Sand Sculpture Artfest

After a year hiatus due to the COVID-19 pandemic, CASA of Grant County announced that its annual Sand Sculpture Artfest will make its return this summer at the Splash House.

The one-day event will be held on Saturday, July 10, beginning at 10 a.m.

As is tradition since the inaugural event in 2008, Splash House's 100 foot by 100 foot sand space located next to the parking lot is divided in 10 foot by 15 foot sections for each team to create their own sculpture. There are no rules or regulations for what teams and individuals can create, and teams are able to use paint, props, and other kinds of accents to bring their sculpture



"We are just really excited to be back," CASA of Grant County Executive Director Leslie Hendricks said. "For us, it's an exciting time. Getting back into family fun, friendly things, this is going to be one of those highlights we hope people will put on their personal calendars."

The goal for the fundraiser is to raise \$20,000, with all the proceeds going to CASA of Grant County in order to help the organization continue its remarkable work in the lives of children in need.

There are two sponsorship levels – one at the \$250 level and another at the \$500 level. Those who sponsor at the \$500 level will be advertised with CASA as a corporate sponsor for the year, and will also be highlighted on social media, on CASA of Grant County's website, and in any printed materials for the event.

Sculpture building will conclude at 3 p.m., and public voting will commence from 3 p.m. until 4 p.m. At the conclusion of the voting, four different awards will be presented. The first is the People's Choice Award, which is given to the best

Scooter ordinace passed to third reading

In a relatively short meeting this past Tuesday, General Ordinance No. 4-2021, an ordinance regulating motorized scooter, was passed to its third and final reading by a unanimous 5-0 margin.

Common Council Vice President Brian Cowgill, in accordance with fellow Councilwoman Robin Fouce, President Deb Cain, Jerry Foustnight, City Engineer Mike Graft, Morrell's Scooters owner Ronald Morrell Jr., and others, believe they have devised an effective ordinance, which will allow the city of Marion to use motorized scooters in a safe and legal manner.

The ordinance will ensure that motorized scooters are operated in a way that is safe for riders, pedestrians, and drivers, and that scooters are parked in a manner that does not clutter the public right-ofway or obstruct access for pedestrians, cars, bicycles, or

"We had a good committee. We went over it with a finetooth comb," Cowgill said.

"This is the best one that we have come up with."

The only comment came from Hands of Hope Director Linda Wilk, who questioned why scooter registration would not go through the Marion Police Department rather than the Code Enforcement department. Since Code Enforcement is inundated with the abandoned houses and landlord ordinances, Wilk wondered if Code Enforcement would also have time to enforce the new scooter ordinance as well as add another

permit for them to process.

Cowgill stated that having the permit process go through Code Enforcement was the most logical scenario since Foustnight and his team already took care of the other permits for the city.

"All other permits in the city go through his office already," Cowgill said. "That's why we went with it."

The final reading of General Ordinance No. 4-2021 will take place at the next Common Council Meeting on Tuesday, June 1.
