# Marion falls to Delta in regional final

As has become tradition over the last several years, the battle between the Marion Giants and the Delta Eagles, two of the top tennis programs in the state, was a fiercely competitive

However, despite a pair of brilliant matches at the No. 1 and 2 singles positions for the Giants, Delta's vast wealth of experience played a crucial role in their 3-2, regional championship triumph.

Despite the fact that girl's tennis was put on hold for a year due to the COVID-19 pandemic, the Eagles returned their entire starting lineup. Conversely, the Giants came into the season with several new

Ultimately, that proved to be the difference.

"One crucial factor when looking at the whole match tonight, from top to bottom, compared to when we played them two years ago...they had all five girls," Marion Head Coach Doug Porter said. "There aren't too many schools in the state of Indiana, especially high-quality teams, that have five varsity players back. That's a luxury Delta had."

However, though the final outcome was not what Porter hoped, he was pleased with his team's

tenacity, grit, and fight throughout the evening.

"You don't want to lose, you hate losing," Porter said. "But [I'm] proud of my team that we...still battled hard and made Delta earn it. Tennis is a team game, it's why it takes three spots to win, and Delta just has more depth than we do, but our girls really fought hard tonight."

Jaden Sebastian put together a spectacular outing at No. 1 singles, defeating Gwendolyn Clark 7-5, 6-3 in a two-and-half-hour match. To date, the junior has compiled a 19-4 overall record, including a 4-0 record in the state tournament.

Marion's second point came at No. 2 singles, where Anna Wuertley emerged victorious in a pair of grueling sets against Abigail Bamidele, 7-5, 7-5. With the win, Wuertley improved her season record to 20-3.

However, those victories came after Delta already had the match in hand with victories at No. 3 singles and both doubles positions.

Graciella Solis put a wrap on a stellar freshman season, dropping a hardfought match to seasoned Delta veteran Maggie Hunt

Overall, Marion's singles players recorded a 59-10 record in 2021, led by
